Radian's estate list is constantly in flux, with a regular turnover of properties coming and going. Kinect provides oversight and clarity, from arranging gas and electricity contracts for new properties to ensuring all relinquished properties are provided with an accurate final bill. Kinect also provides invoice verification services for the whole portfolio to ensure all invoices are accurate. Any invoicing errors are highlighted and reported on a monthly basis, with Kinect following every error through to its resolution. In 2016, Kinect Energy Group:*
